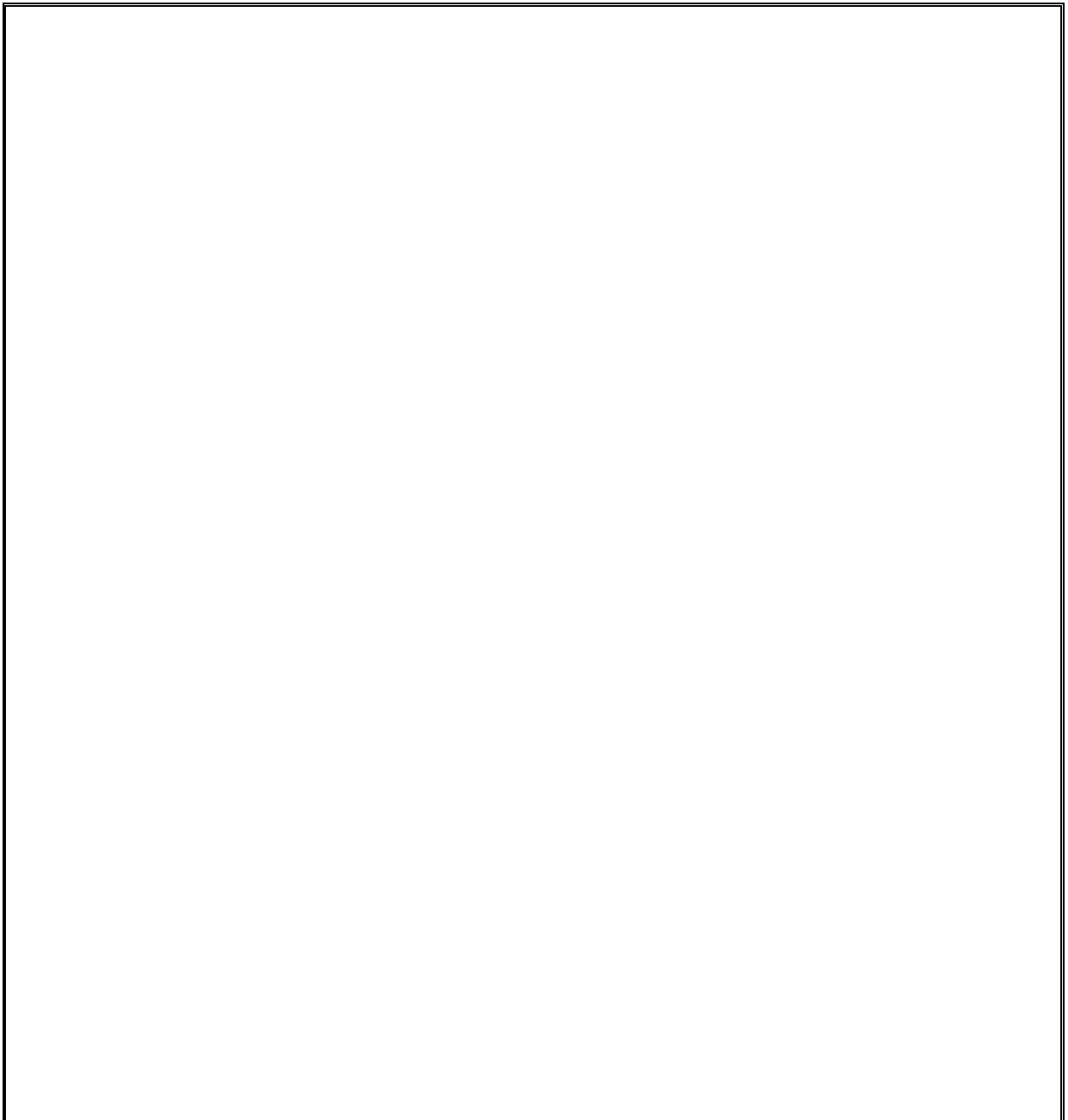

The presence and attitude of a member shall at all times benefit the Society, members of the Society and the breed as such.
