## INSPECTORS MAY REFUSE TO HANDLE INSPECTIONS UNLESS THE FOLLOWING REQUIREMENTS ARE COMPLIED WITH:

1. All animals presented for inspection must be **PROPERLY BRANDED** according to the required Nguni method of identification as described in our by-laws.
2. Inspection lists can be drawn from LOGIX (Reports/Admin. Reports/ Inspection List). All the animals that are due for inspection will appear on this list. Please check that all animals being presented for inspection, appear on your list. If any animals appear on the list, but are no longer in your possession, please arrange with SA Studbook (Ivonne van Tonder) for their transfer or cancellation.
3. If an inspection list cannot be obtained, the inspection book must be filled in correctly and completely. Male, female and first registration (FR) animals must be filled in on separate pages and birth notification certificates (where applicable) must be attached.
4. Bulls may be inspected from two years (24 months) and heifers from one year (12 months) of age. Female animals on the calf book should be inspected before the age of 36 months (3 years).
